

**RESOLUTION NO. 2025-35**

**A RESOLUTION OF THE VILLAGE COMMISSION OF THE VILLAGE OF BISCAYNE PARK, FLORIDA, AUTHORIZING THE EXPENDITURE OF AMERICAN RESCUE PLAN ACT (“ARPA”) FUNDS IN AN AMOUNT NOT TO EXCEED \$15,000.00 TO COMPENSATE YOLANDA AGUILAR CONSULTING SERVICES INC., FOR WORK PERFORMED IN CONNECTION WITH COMPLIANCE AND REPORTING REQUIREMENTS ASSOCIATED WITH ARPA FUNDS FOR SERVICES COMMENCING ON APRIL 23, 2025 THROUGH MARCH 30<sup>TH</sup>, 2026, AS APPROVED BY THE VILLAGE COMMISSION IN RESOLUTION 2025-28 AS AUTHORIZED BY THE 2022 US DEPARTMENT OF TREASURY CORONAVIRUS STATE AND LOCAL FISCAL RECOVERY FUNDS FINAL RULE; AUTHORIZING THE TRANSFER OF ARPA FUNDS TO THE GENERAL FUND; AUTHORIZING THE VILLAGE MANAGER AND FINANCE DIRECTOR TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, on May 6, 2025, the Village Commission approved a Professional Services Agreement with Yolanda Aguilar Consulting Inc. (“Consultant”) to provide consulting services to the Village related to the administration of American Recue Plan Act Funds (“ARPA” or “Act”), in an amount not to exceed \$15,000.00 (See Resolution 2025-28); and

**WHEREAS**, the services provided to the Village by the Consultant include assisting the Village in the mandatory reporting and compliance requirements of the Act to ensure the Village’s compliance with all applicable rules established by the U.S. Department of the Treasury in connection with the \$1,535,116.00 awarded to the Village as a Lost Public Sector Revenue Replacement due to the COVID-19 Pandemic; and

**WHEREAS**, the 2022 U.S. Department of the Treasury Coronavirus State and Local Fiscal Recovery Funds Final Rule authorizes the use of the funds for costs related to the administration of the ARPA Program; and

**WHEREAS**, the Village Manager has determined that the payment of the Consultant’s fees is a permissible use of ARPA Funds and recommends that ARPA Funds in the amount of \$15,000 be transferred from the ARPA Fund to the General Fund for payment of services rendered by the Consultant related to the administration of the ARPA Program.

**NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COMMISSION OF THE VILLAGE OF BISCAYNE PARK, FLORIDA, that:**

**Section 1. Incorporation of Recitals.** The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


**Section 2. Approval of the Transfer of Funds.** The Village Commission, based on the recommendation of the Village Manager, hereby authorizes the transfer of ARPA funds, not to exceed

\$15,000.00, to the General Fund for payment for Services rendered by Yolanda Aguilar Consulting, Inc. relating to the administration of the ARPA Program.


**Section 3. Authorization of Village Manager and Finance Director.** The Village Manager and the Finance Department are hereby authorized to transfer said funds from the ARPA Fund to the General Fund and do all things necessary to effectuate this Resolution.

**Section 4. Effective Date.** This Resolution shall be effective immediately upon its passage and adoption.


